Warrant: The Board signed the 2021 warrant. Articles on the warrant are:

Town Meeting: The Board and Moderator Dan Hazelton discussed town meeting procedures. Voting on the March 9th (election of officers) will be held at the Town House with the same COVID-19 procedures as in 2020 voting. The business portion of town meeting (Articles 2 through 9) will be held on March 10 at the Mascoma High School auditorium, which will allow ample social distancing. As required by statute, a bus will provide transportation for those who request it from the Town House to the high school and back. Town meeting begins at 7 p.m. thus the bus will leave at 6:30 p.m. sharp. Masks and sanitizer will be made available. Butler Bus Company is providing the bus and driver at no cost. The Board concurred the town shall give the driver a \$50 gratuity. Danny will follow up with the town clerk to be sure the ballots will be ready.
